# ROCKLIN UNIFIED SCHOOL DISTRICT JOB DESCRIPTION



JOB TITLE: Principal, High School

#### **SUMMARY**:

The High School Principal directs and coordinates educational, administrative, and counseling activities of a high school. He/she provides instructional and administrative leadership at the school site over curriculum, budget, operations, guidance, students, and staff. He/she participates in the formulation of district policy and provides a link between the district and the community.

The High School Principal manages in an environment of single subjects in multiple classrooms where the curriculum requires a complex master schedule with full-time counselors are on site, and the environment is characterized by career exploration, scholarship and college counseling, teaching progress towards graduation, challenges in campus security and discipline, and a variety of extra-curricular activities and sporting events.

Reporting to this position are the following certificated and classified titles: Assistant Principal, Teacher, Counselor, Principal's Secretary, Secretary to the Assistant Principal, Discipline Technician, Campus Monitor, Clerk Receptionist, and other various clerical positions. This position is responsible for the overall direction, coordination, and evaluation of these positions. Carries out management responsibilities in accordance with the school district's policies and applicable laws. Responsibilities include interviewing, hiring, and training employees; planning, assigning, and directing work; evaluating performance; supervising employees; addressing complaints and resolving problems.

**SUPERVISOR:** This position reports directly to the Assistant Superintendent, Curriculum and Instruction.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

The essential duties and responsibilities for this position include, but are not limited to, the following:

- 1. Provides leadership for the development of instructional goals and objectives of the school/district.
- 2. Establishes a learning climate which supports the instructional goals and objectives of the school.

- 3. Evaluates student progress/needs.
- 4. Provides clear and consistent direction which is characterized by openness, honesty, and fairness.
- 5. Available to staff, students, parents, and the community on a regular basis.
- 6. Contributes to the development of district programs and policies in consort with others.
- 7. Provides leadership for the development of inservice/staff development programs.
- 8. Involves appropriate personnel in the selection of staff.
- 9. Demonstrates effective personnel management practices.
- 10. Provides leadership for the establishment and maintenance of discipline standards.
- 11. Utilizes effective plant management practices.
- 12. Administers the school site budgets in accordance with district policy and procedure.
- 13. Assigns all students in such a way as to encourage their optimum growth.
- 14. Develops plans and organization structures for school site.
- 15. Assesses the progress of the students.
- 16. Guides staff in the determination of long-range plans and current goals and objectives.
- 17. Participates in the development and implementation of district-approved curriculum, integrating it with the needs of the individual school.
- 18. Assists in screening and interviewing candidates. Recommends appointments and assignments of staff members.
- 19. Plans, organizes, and directs the business operations of the school site, including budgets, in accordance with district policies and procedures.
- 20. Supervises and evaluates performance of assigned personnel in accordance with the district's adopted uniform guidelines for evaluation and assessment. Recommends corrective action in cases of substandard performance. Counsels staff on career development. Ensures optimum development of student potential by monitoring placement and progress, guidance and counseling.

- 21. Directs usage of site resources such as curriculum materials, instructional supplies, equipment, building, grounds, and volunteers.
- 22. Communicates effectively with parents about programs, individual student progress, and parent participation. Leads the district's community relations programs at the site.
- 23. Services as district officer in management, certificated, and classified employee relations. Communicates and interprets district policy to site staff.
- 24. Plans, coordinates, and reviews the work of resource teachers and support personnel.
- 25. Develops site specific practices and procedures for health, safety, SBA, and discipline within overall district guidelines.
- 26. Requisitions and allocates supplies, equipment, and instructional material as needed.
- 27. Directs preparation of class schedules, cumulative records, and attendance reports.
- 28. Monitors the safety and security of the school building and property.
- 29. Attends and supervises school activities such as assemblies and sporting events.
- 30. Plans and monitors the school budget.
- 31. Performs various duties of absent regular staff, both classified and certificated.
- 32. Attends school and district meetings.
- 33. Performs related duties as required.
